I am pleased to share the following resource guide on how to submit Community Project Funding (CPF) proposals through the annual appropriations process for Fiscal Year (FY) 2027. This guide is designed to help streamline the appropriations process and provide you with information available in a clear and concise format. As a member of the United States House of Representatives, my team and I are committed to creating a fair and equitable process that will be beneficial to California's 29th Congressional District (CA-29).

In this guide, you will find an overview of the appropriations process, the CPF process, answers to frequently asked questions, staff contact information, and a brief overview of alternative federal funding sources.


My team and I are looking forward to your recommendations on CPF requests that will benefit those who live and work in CA-29. Members may request funding for state, local, or tribal governmental grantees and certain eligible non-profits, as allowed under federal law and House Appropriations Committee guidance, and must have community support.

As you prepare your requests, please keep in mind that my office will receive far more CPF requests than can be submitted. Based on the Fiscal Year 2027 guidance, each Congressman may only submit up to 20 projects for the review of the House Appropriations Committee. Submission from my office to the House Appropriations Committee does not guarantee the project will be approved or funded. Projects are approved for funding when the House and Senate appropriations bills are approved, and the President signs the bill into law.

That is why it is extremely important that every project and requestor pursue other funding opportunities where available. My team and I are here to help you secure these important resources.

Thank you again for your interest in this year's CPF process. With the help of community members like you, **my office was able to secure nearly \$15 million in federal funding for CA-29 through 15 CPF requests in FY26.** My team continues to be available to answer your questions as needed. I look forward to working with you to bring needed federal resources to the San Fernando Valley.

Background

In previous Fiscal Years (FY), the House Appropriations Committee accepted Community Project Funding (CPF) submissions from Members of Congress.

The deadline for all submissions is by 5:00pm EST on Friday, March 6, 2026. While this is a tight turnaround, this is based on the House Appropriations Committee (Majority) timeline. And it is important to submit soon so the Office can work with entities to ensure complete and strong applications.

The CPF process is a way for Members of Congress to bring direct support to their district by requesting funding for state, local, or tribal governments, and eligible non-profit entities.

House offices can only submit a specified number of requests that meet all guidelines set forth by the House Appropriations Committee (Majority). **This guide has been updated based on official FY27 guidance that was released on February 25, 2026.**

We cannot guarantee that requests submitted after the deadline will be considered. If you have problems or questions while completing these forms, please feel free to contact the office. What is the difference between Programmatic and Language requests and Community Project Funding requests?

Programmatic – A request for a specific funding level for a federal program.

Language – A request to include specific bill or report language that does not direct funding to a particular entity but encourages, urges, or directs some type of action.

Community Project Funding – directs funds to state, local, tribal governments, and eligible non-profits.

This guide will only cover CPF requests. All applications for CPFs must be submitted to our office via a [downloadable form available on my website](#).

Requirements for Projects:

Community Support

- Successful CPF requests must be able demonstrate a high degree of community support. Examples include:
 - Letters of support from elected community leaders (e.g. mayors or other officials).
 - Press articles highlighting the need for the requested CPF.
 - Support from newspaper editorial boards.
 - Projects listed on state intended use plans, community development plans, or other publicly available planning documents.
 - Resolutions passed by city councils or boards.

Financial Disclosure

- CPF requests cannot have any financial ties to the Member of Congress or their immediate family.

Member Requirement to Post All Requests Online

- Members are required to post CPF requests on their house.gov websites at the time the request is made to the Committee. The information posted must include:
 - The proposed recipient;
 - The address of the recipient;
 - The amount of the request;
 - An explanation of the request, including purpose, and a justification for why it is an appropriate use of taxpayer funds; and
 - The Member's signed certification letter stating there is no financial interest in the project.
- We will make this information publicly available for all successful applications.

What criteria will be used to evaluate CPF requests?

- **Ban on for-profit recipients.** Under FY27 House Appropriations Committee guidance, for-profit entities are not eligible CPF recipients.
- **Matching requirements.** Several Federal programs eligible for CPF requests require a state or local match for projects either by statute or according to longstanding policy. The House will not waive these matching requirements for CPF requests. It is important that applicants have the ability to meet matching requirements prior to requesting a project. Note: This does not mean that matching funds must be in-hand prior to requesting a project, but successful requests must have a plan to meet such requirements in order for such a project to be viable.

- **One-year funding.** Each project request must be for FY27 funds only and cannot include a request for multiyear funding.
- **State, local, or tribal governmental entities as grantees.** Members may consider public entities as primary grantees to oversee the completion of the project.
- **Non-profits as grantees.** If the applicant is a non-profit organization, they will need to provide evidence that the recipient is a non-profit organization as described under section 501(c)(3) of the Internal Revenue Code of 1986. Further, many water projects often partner with non-profit entities to complete projects. Therefore, projects may also be directed to non-profits with an inherently governmental function.

What additional items should I be aware of related to CPF requests?

- **Cap on overall funding.** The House Appropriations Committee will limit CPFs to no more than one percent of discretionary spending.
- **“Support” vs. “Request” for a project.** Anything short of a formal request will not be considered for inclusion.
- **Letters of Support.** Every time a Member signs a letter demonstrating support for a project, the Member should append an accompanying disclosure certifying to the House Appropriations Committee Chair and Ranking Member that the Member has no financial interest in the project. This is to ensure the highest ethical standards in the CPF process.
- **Lobbyists, donors and other affiliated parties.** While Members are required to certify to the House Appropriations Committee that neither they nor their immediate family have a financial interest in the proposed project, Members should also be fully aware of any other financial aspects or relationships associated with the proposed project that might raise ethical concerns. These include, but are not limited to lobbyists, donors, or other affiliated parties that have an interest in the project.
- **“One-stop” webpage for the public.** The House Appropriations Committee will maintain a website with links to all Members’ appropriations project requests to help the public easily view them.
- **Transparency and Early Public Disclosure.** Per House rules, each bill’s Committee report will include a list identifying each community project that has been funded in the bill along with the name of the Member requesting it. Each Subcommittee will make such lists public at the time of their Subcommittee markup.
- **Audits and Oversight:** The Government Accountability Office (GAO) will conduct an independent audit of a sample of enacted projects and report its findings.

What projects are eligible?

Only certain accounts will be available for CPF in each subcommittee of the House Appropriations Committee. For FY27, CPFs are available for 32 accounts. The House Appropriations Committee has the discretion to change which accounts are available for future fiscal years. A summary of the available subcommittees are listed below.

However, it is important to note that CPFs represent only a small fraction of the discretionary funding available through competitive grants, loans, and other opportunities.
